

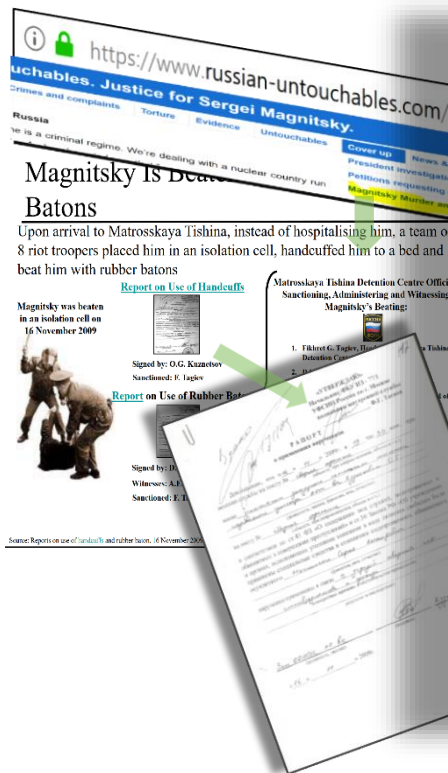
Browder's claim of "use of batons," backed by fake document.

I report that on « 16 » November 2009 at 19 hr. 30 min., while serving in post No. gathering section
(in object, under convoy, on patrol, etc.)

by myself, the deputy assistant on duty of the head of the pre-trial detention unit Lieutenant of the internal service Kuznetsov O. G.

Apart from not mentioning batons or saying anything about Magnitsky being beaten, it explicitly states that he was placed in handcuffs, not

as the story Browder claims it corroborates says, in order to harm him, but instead out of concern that he would harm himself.

Moreover, this accords exactly with what's said in The Moscow Public Oversight Commission [report](#). It tells us that, on the night he died, Magnitsky began to act very erratically, the doctor thought his behavior "looked like acute psychosis and delirium of persecution," so "[t]hey called for psychiatric emergency" and "[t]hey put handcuffs on Magnitskys hands."

The second is an illegitimate document since there is no such form and the relevant law doesn't authorize use of batons. The form was Photoshopped, traced or otherwise created by some entity other than the Russian government. It is exactly the same as the first, even for the title about use of handcuffs, except for the addition of red underlined words "batons were applied."

This is used to "prove" the photo claim that Magnitsky was beaten.

Batons

Upon arrival to Matrosskaya Tishina, instead of hospitalising him, a team of 8 riot troopers placed him in an isolation cell, handcuffed him to a bed and beat him with rubber batons

Magnitsky was beaten in an isolation cell on 16 November 2009
