

Marc Rowan in the Epstein Files

Executive Summary

The released files contain **388 documents** mentioning Marc Rowan, spanning from 2013 to 2018. They reveal a **significant and ongoing professional relationship** between Rowan and Jeffrey Epstein, characterized by:

1. **Frequent social meetings** (primarily breakfasts)
 2. **Detailed technical discussions** about complex financial instruments
 3. **Strategic tax planning conversations**
 4. **Business introductions and deal discussions**

Key Findings by Category

1. Meeting Frequency and Pattern

The documents show a consistent pattern of **regular breakfast meetings** at Epstein's residence/office:

- **2013:** Multiple meetings scheduled, including September 3, October 22-23
- **2015-2016:** Extensive breakfast meetings in January and December
- **January 6, 2016:** Multiple calendar entries showing "8:00am BREAKFAST w/Marc Rowan"
- The consistency suggests an ongoing advisory or consulting relationship, not isolated encounters

2. Tax Receivable Agreement (TRA) Discussions

Critical documents (EFTA00832526, EFTA00831849, EFTA00833764, EFTA02469635, EFTA02400399, EFTA02470328) show detailed technical exchanges:

- **"TRA Valuation Process"** email chain (March 3-4, 2016): Rowan forwards detailed valuation worksheets to Epstein, with Epstein responding: *"Ask to see the worksheet with numbers"*
- **"marc , the tra liability amount is on apollo's balance sheet. can you find"** (EFTA00833764)
- **"did we ever get the worksheet calculation for the tra number on the balance sheet?"** (EFTA00831849, EFTA02470286)
- These demonstrate Epstein was deeply involved in analyzing Rowan's personal and Apollo-related TRA valuations

3. Corporate Inversions and Rothschild Discussions

Most significant strategic discussions (EFTA00833330, EFTA02470280):

- February 25, 2016: Epstein writes to Rowan: *"i can join the call if you think appropriate. using rothschild for the inversion allows interesting structures"*
- Rowan responds: *"They are gathering information and I have a call with them early next week."*
- This confirms your earlier point about discussing **corporate inversions** using Rothschild to create "interesting structures" for shifting corporate domiciles

4. Direct Evidence of Financial Worksheets

Multiple documents reference specific worksheets:

- EFTA00833950 / EFTA01185180: Epstein sends Rowan a file named **"Black_Family_Partners_9-3-15_(tra).pdf"**
- EFTA00833958 / EFTA02704093: Another attachment: **"Black_Family_Partners_12-3-15_(tra)(1).pdf"** with Epstein noting *"done three months"*
- EFTA02400399: Chris Weidler (Apollo) provides detailed TRA analysis to Rowan, which Rowan forwards to Epstein: *"Marc Not to be confusing but one point... This we have done in 13 and 14 as there were rate changes."*

5. Personal Financial Discussions

- EFTA01731997: Someone alerts Epstein: *"APO stock sales by Marc Rowan... i see that he has sold 1,588,139 shares of stock"*
- EFTA00833959-33961: Detailed discussion about valuing "shares not the units" regarding the "empire" investment
- EFTA01742970 / EFTA02704647: Exchange about a *"goofy description, ie puts did not take into account termination clause"*

6. Direct Evidence of TRA Payments

Most concrete financial evidence (EFTA02713903-13904, EFTA00662880-62881, EFTA00602688-02689):

- Tax documents titled **"Tax Related Payment Summary For the Year Ended 12.31.2013"**
- Explicitly listing: **"TRA Holder: Marc Rowan"**
- These are official records of Rowan receiving payments under Tax Receivable Agreements

7. Business Introductions and Networking

- **EFTA02361689:** Perry Shwachman (Sidley Austin partner) included on emails with Rowan and Epstein regarding legal matters
- **EFTA00827144-27147:** References to lawsuits involving *"Apollo, Marc Rowan and David Sambur"*
- **EFTA02466137:** Rowan forwards Epstein an email: *"Good to see you last Friday - Edmond de Rothschild"*

8. Personal Assistant Coordination

Extensive emails between Rowan's assistant (Elizabeth Irene) and Epstein's assistants (Lesley Groff, Melanie Spinella) showing:

- Coordination of schedules
- Sharing of cell phone numbers
- Confirming meeting locations at Apollo's offices (9 West 57th Street) and Epstein's residence

Important Context

- **No Allegations of Criminality:** None of these documents suggest Rowan participated in or knew of Epstein's sex trafficking
- **Post-Conviction Relationship:** All documented interactions occurred **after Epstein's 2008 conviction**
- **Professional Focus:** The discussions are exclusively about legitimate (though aggressive) tax and financial strategies
- **Rowan's Position:** At the time, Rowan was a senior executive and co-founder of Apollo Global Management

The files paint a picture of Epstein operating as a **trusted financial advisor and strategic sounding board** to one of Wall Street's most powerful figures, engaging in sophisticated discussions about tax minimization strategies that are legal but controversial.
